

Privacy Policy

At BubbleScene Ltd. we are committed to protecting and respecting your privacy.

Scope of Policy

This policy applies to your use of:

- Bubblo mobile application software (App) Android version OR Apple IOS version hosted at <http://store.apple.com/uk/search/apps> (App Store), once you have downloaded a copy of the App onto your mobile telephone or handheld device (Device).
- Bubbloapp website (Website) available at www.bubbloapp.com
- Any of the services accessible through the App and Website (Services) that are available on the App or Website (Our Sites) unless the EULA states that a separate privacy policy applies to a particular service, in which case that privacy policy only applies.

This policy sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it.

For the purpose of the Data Protection Act 1998, the data controller is BubbleScene Ltd. of 118 Pall Mall, London, SW1Y 5ED.

Information we may collect from you

We may collect and process the following data about you (Submitted Information):

- Information that you provide by filling in forms on Our Sites, including the Device's telephone number. This includes information provided at the time of registering to use Our Sites, subscribing to any of the Services, posting material or requesting further services. We may also ask you for information when you report a problem with any of Our Sites.
- Additional Information:
 - If you contact us, We may keep a record of that correspondence;
 - We may also ask you to complete surveys that We use for research purposes, although you do not have to respond to them;
 - Details of transactions you carry out through any of Service Sites and of the fulfillment of your orders;
 - Details of your visits to any of Our Sites including, but not limited to, traffic data, location data, weblogs and other communication data and

the resources that you access whether this is required for our own billing purposes or otherwise;

- **Device information:** We may collect information about the Device or any computer you may use to download or access Our Sites, including, where available, the Device's or computer's unique Device identifiers, operating system, browser type and mobile network information as well as the Device's telephone number, for system administration and to report aggregate information to our advertisers. We may associate Device information with Submitted Information and will treat the combined information as personal data in accordance with this policy for as long as it is combined.
- **Location information:** when you use of our location-enabled Services, We may collect and process information about your actual location. Some of these Services require your personal data for the feature to work. If you wish to use the particular feature, you will be asked to consent to your data being used for this purpose. You can withdraw your consent at any time by disabling location services for Our Sites on your device.
- **Log information:** when you use the Services or view content on Our Sites, We may automatically collect and store certain information in server logs, including but not limited to internet protocol (IP) addresses, internet service provider (ISP), clickstream data, browser type and language, viewed and exit pages and date or time stamps.
- **Unique application numbers:** when you install or uninstall a Service containing a unique application number or when such a Service searches for automatic updates, that number and information about your installation, for example, the type of operating system, may be sent to us.

Cookies

Our Sites use cookies to distinguish you from other users of Our Sites. This helps us to provide you with a good experience when you use the App or browse Our Site and also allows us to improve the App and Our Sites.

Where We store your personal data

The data that We collect from you may be transferred to, and stored at, a destination outside the European Economic Area (EEA). It may also be processed by staff operating outside the EEA who work for us or for on of our suppliers. These staff may be engaged in the fulfillment of your request, order or reservation, the processing of your payment details and the provision of support services. By submitting your personal data, you agree to this transfer, storing or processing. BubbleScene Ltd. will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy.

All information you provide to us is stored on our servers. Any payment transaction carried out by us or our chosen third-party provider of payment processing services will be encrypted using Secured Sockets Layer technology (SSL). Where We have given you (or where you have chosen) a password that enables you to access certain parts of Our Sites, you are responsible for keeping this password confidential. We ask you not to share a password with anyone.

Unfortunately, the transmission of information via the internet is not completely secure. Although We will do our best to protect your personal data, We cannot guarantee the security of your data transmitted to Our Sites; any transmission is at your own risk. Once We have received your information, We will use strict procedures and security feature to try to prevent unauthorized access.

We may collect and store personal data on your Device (Cookies) using application data caches and browser web storage (including HTML 5) OR other technology.

When using certain Services including Chat ensure that you do not submit any personal data that you do not want to be seen, collected or used by other users.

If you are an existing customer, We will only contact you by electronic means (Chat, e-mail or SMS) with information about goods and services similar to those that were the subject of a previous sale to you.

We do not disclose information about identifiable individuals to our advertisers, but We may provide them with aggregate information about our users (for example, We may inform them that 1000 men aged under 25 have clicked on their advertisements on any given day). We may also use such aggregate information to help advertisers reach the kind of audience they want to target (for example, women in Covent Garden). We may make use of the personal data We have collected from you to enable us to comply with our advertisers' wishes by displaying their advertisement to that target audience.

Disclosure of your information

We may disclose your personal information to any member of our group, which means our subsidiaries, our ultimate holding company and its subsidiaries, as defined in section 1159 of the Companies Act 2006.

We may disclose your personal information to third parties:

- In the event that We sell or buy any business or assets, in which case We may disclose your personal data to the prospective seller or buyer of such business or assets.
- If BubbleScene Ltd. or substantially all of its assets are acquired by a third party, in which case personal data held by it about its customers will be one of the transferred assets.

- If We are under a duty to disclose or share your personal data in order to comply with any legal or regulatory obligation or request.
- In order to:
- Enforce or apply other agreements or to investigate potential breaches; or
- Protect the rights, property or safety of BubbleScene Ltd. our customers, or others. This includes exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction.

Your rights

You have the right to ask us not to process your personal data for marketing purposes. We will usually inform you (before collecting your data) if We intend to use your data for such purposes or if We intend to disclose your information to any third party for such purposes. You can exercise your right to prevent such processing by checking certain boxes on the forms we use to collect your data. Access to information

The Data Protection Act 1998 gives you the right to access information held about you. Your right of access can be exercised in accordance with that Act. Any access request may be subject to a fee of £10 to meet our costs in providing you with details of the information We hold about you.

Changes to privacy policy

Any changes We may make to our privacy policy in the future will be posted on this page and, where appropriate, notified to you by e-mail **OR** notifying you of a change when you next start the App or log onto the Website. The new terms may be displayed on-screen and you may be required to read and accept them to continue your use of Our Sites or the Services.
